The following scenarios are common voting practices for PRISM's Board of Directors, which are extended to particular members due to their various types of program participation, and the following information documents these practices.

- **Yolo County/YCPARMIA**

- Yolo County – Medical Malpractice, Dental
- YCPARMIA – Excess Workers' Compensation, Property
  - Yolo County participates in the Excess Workers' Compensation and Property Programs through YCPARMIA.

**\*\*\*Yolo County** can vote for items under the Excess Workers' Compensation Program due to participating in the Program through YCPARMIA.

- **Glenn County/GSRMA**

- Glenn County – Medical Malpractice
- GSRMA – Excess Workers' Compensation, General Liability 1, Property, EIAHealth, Dental
  - Glenn County participates in the Excess Workers' Compensation, General Liability 1, and Property Programs through GSRMA.

**\*\*\*Glenn County** can vote for items under the Excess Workers' Compensation and General Liability 1 Programs due to participating in both Programs through GSRMA.

- **Sacramento County/Sacramento County Contracts**

- Sacramento County – Excess Workers' Compensation, General Liability 2, Property
- Sacramento County Contracts – Primary Workers' Compensation, Excess Workers' Compensation, General Liability 1

**\*\*\*Sacramento County** can vote for items under the General Liability 1 Program because Sacramento County Contracts has been grouped under Sacramento County.

- **San Bernardino County/San Bernardino Departments**

- San Bernardino County – Excess Workers' Compensation, General Liability 2, Property
- San Bernardino Departments – General Liability 1

\*\*\***San Bernardino County** can vote for items under the General Liability 1 Program because San Bernardino Departments has been grouped under San Bernardino County.

- **Trindel Insurance Fund**

- Alpine County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, Dental
- Colusa County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, Dental
- Del Norte County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, PRISMHealth
- Lassen County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, Dental
- Modoc County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, Dental
- Mono County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, Dental
- Plumas County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, Dental
- San Benito County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, PRISMHealth, Dental
- Sierra County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, Dental (PRISMHealth through SDRMA)
- Sutter County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, PRISMHealth, Dental
- Trinity County – Excess Workers' Compensation, General Liability 1, Medical Malpractice, Property, Dental
- Trindel Insurance Fund – General Liability 1
