## **Annual Budget**

The Board *approved the 2022/23 budget* as proposed, along with the publicly available pay schedule. Both documents will be posted to the PRISM website shortly. Total budgeted revenues are \$1.65B, budgeted expenses are \$1.58B, and budgeted Net Position is \$260.8M by the end of the fiscal year.

## **Excess Workers' Compensation (EWC) Program**

Highlights of the Board's review and actions for the EWC Program are as follows:

- The remaining components of the renewal were finalized (approved terms for renewal of the pool layer reinsurance with Great American, determined to selfinsure the COVID-19 exposure in the pool and \$45M xs \$5M layers, and transfer the Program corridor risk to PRISM ARC).
- The allocated *administrative fees were reduced* to match the 2022/23 budget.
- Authority was delegated to the PRISM CEO and Underwriting Committee Chair to execute a *commutation of the 2021/22 statutory policy with Liberty* within 100 days of expiration, if it makes sense to do so.

# **General Liability 1 (GL1) Program**

Highlights of the Board's review and actions for the GL1 Program are as follows:

- Final renewal terms for all of the excess layers were reviewed.
- Approval was given to transfer the Program's corridor risk in the \$9M xs \$10M layer to PRISM ARC, providing a 3% (or \$150k) discount to the members.
- The allocated *administrative fees were reduced* to match the 2022/23 budget.
- The Board approved **amendments to the MOC** to be effective with the July 1, 2022 renewal.

#### **Informational Reports**

The Board received several informational reports, a few of which are noted below:

- company) including efforts to expand outside of California, recent legislative activity, and updates related to technology and services.
- Chandler Asset Management provided an overview of the PRISM investment portfolio.
- A *renewal synopsis* was provided in the agenda packet, and *updated premium estimates* are in the process of being distributed to the members.
