Legislative Activity

PRISM Lobbyist, Jason Schmelzer, provided an update on the end of the legislative session.

Staff provided a summary of the 2021 legislative session and outcomes of the bills the committee was following:

The Committee reviewed 178 bills this legislative session:

- 5 had a Support position
- 31 had an Oppose position
- 1 had a Concerns position
- 98 had a Watch position
- 42 were dropped

At the end of the session, 88 bills are two-year bills:

- 20 had an Oppose position
- 5 had a Watch position

47 bills made it to the Governor's desk:

- 39 were signed by the Governor (35% of our bills)
- 9 had an Oppose/Concerns position
