Legislative Activity

PRISM Lobbyist, Jason Schmelzer, provided an update on the legislative session. The 2021 session ends tomorrow, September 10th. There was talk regarding possible legislation on vaccine mandates for all employers along with an extension of the SPL; however it did not move forward. The Governor recall election is next Tuesday on September 14th. The Governor is polling well and appears to be in the lead as his campaigning continues.
