Merger of Member Services & Risk Control Committees

Staff gave an update on the status of the merger of the Member Services and Risk Control Committees. Executive Committee approved the merger and the combined committee will begin as of January 1, 2023.

Certificate of Insurance (COI) Management Service Update

The contract with certificate of insurance management company Ebix is set to expire, and they are proposing a 9% rate increase as well as a minimum annual fee. After a discussion, the Committee directed staff to move forward with an updated contract Ebix.

Enterprise Risk Consultants (ERC) Program–Approved Service Areas

Committee discussed the intent of the scope of services offered through the ERC Program, and the pros and cons of adding additional categories. The Committee directed staff to develop a general, flexible category, and bring the name and description back to the Committee at the next meeting.

The Committee reviewed one application for the ERC Program, approving the applicant for all applied areas of expertise, except for the area of Risk Analyst, requesting more information to further consider that area.
