Selection of Chair and Vice Chair

The Committee reelected Brendan Shannon of San Diego Metropolitan Transit System as Chair, and Coral Ferrin of Tehama County as Vice Chair of the PRISMHealth Committee for 2026.

Member Statistics and Program Performance Report (PPR) Update

Staff reported on member statistics for the 2025 plan year. Staff informed the Committee that the PPR updated through December 31, 2025, is being finalized and will be delayed. The estimated 2026 premium volume is \$930M.

New Member Application

The Committee approved the California Intergovernmental Risk Authority (CIRA) for membership in the PRISMHealth Program, large member segment, effective July 1, 2026. Staff said that CIRA would participate in the Program in representation of its member agencies, serving as the contracting entity on behalf of their underlying members.

2025 Open Enrollment Report

Alliant presented the 2025 Open Enrollment results. Especially noteworthy were the numerous issues with Navitus, primarily due to the transition from Express Scripts, and Digbi Health due to a confusing preregistration process, no clear instructions on next steps, and overall poor feedback on the GLP-1 medication process.

Other Matters

- The Committee acknowledged receipt of the Disclosure of Underwriting Authority for Small Group, and the Code of Conduct.
- The Committee was provided with the PRISM Organizational Strategic Plan.
- Staff shared that the PRISM Orientation is scheduled for April 1, 2026.
- Staff informed the Committee that the 2026 PRISM Employee Benefits Symposium registration is underway and encouraged members present to register themselves and/or their staff.
