# <u>Pharmacy Benefit Management RFP Update and Express Scripts (ESI) Contract Extension</u>

The Committee approved a 1-year extension to the ESI contract, effective January 1, 2024, through December 31, 2024, to allow Alliant more time to review data discrepancies associated with the Request for Proposal (RFP) and continue to pursue the best pharmacy option for the PRISMHealth Program.

### New Member Application - Ventura County Deputy Sheriff's Association

The Committee approved Ventura County Deputy Sheriff's Association (VCDSA) for entry into the PRISMHealth Program, large member segment, effective January 1, 2024, contingent upon the express approval and agreement of Ventura County to execute the PRISMHealth MOU on behalf of VCDSA. The Committee requested clarification about the role of the County in Program decisions for VCDSA.

# **2024 Benefit Administration**
